## Rules and Garage Rental Policies

**The garage renter, for a specific event from the previous season, has the right of first refusal to reserve the same garage the next year. The renewal deadline for this consideration is May 31, 2018.**

**No refunds will be made on cancellations unless the garage can be rented to another participant. Cancellation requests should be made to Scott Ontjes, 937-439-5665, or emailed to [scott@ontjes.net](mailto:scott@ontjes.net).**

As partial consideration for the covenants and agreements on the part of Green Savoree Mid-Ohio, LLC, and BMW CCA Buckeye Chapter, Inc. set forth herein, Lessee agrees to comply with the following requirements during all times that this agreement is in effect:

- (1) No signage of any type shall be placed on the **exterior** of any garage building or doors.
- (2) **Garages shall not be sublet to others.**
- (3) No welding or open flames of any kind shall be permitted in garages, and no fuel shall be stored therein.
- (4) Garage beams shall not be used for hoisting purposes.
- (5) Mid-Ohio Sports Car Course is not responsible for cars or equipment in the garage(s).  
Buckeye Chapter BMW CCA, Inc. is not responsible for cars or equipment in the garage(s).
- (6) At no time shall Lessee permit more than two (2) cars to be kept in any one garage. Further, lessee agrees that at all times it shall use said garage(s) in a careful and safe manner and keep the floor neat and clean and free of all debris.
- (7) Lessee shall fully comply with all posted rules and regulations. In the event of any dispute, the decision of Green Savoree Mid-Ohio, LLC's Safety Services Manager (or designated agent) shall be final and binding.
- (8) Lessee at all times will be responsible for the conduct of all guests, employees, and agents and will take all precautions in order to avoid accidents and insure their safety and insure the safety of others.
- (9) Lessee will be responsible for the removal cost of any waste, hazardous or otherwise, including, but not limited to, fuel, oil, batteries or tires left on the premises by the Lessee or any participants.

Lessee will be held responsible for any undue damages to the Mid-Ohio Sports Car Course facility and/or its garages. Lessee agrees for itself and its employees, agents, drivers, crew members, guests, and invitees to fully protect, indemnify, and save harmless Green Savoree Mid-Ohio, LLC, and Green Savoree Mid-Ohio, LLC's officers, directors, employees, and agents, and BMW CCA Buckeye Chapter, Inc. and its officers and staff members from any and all liability to third persons or property of third persons resulting from Lessee's use of said garage(s). Lessee agrees that it shall require all of its employees, agents, drivers, crewmembers, guests, and invitees to sign the standard waiver and release form furnished by Green Savoree Mid-Ohio, LLC prior to admission of any such persons to Mid-Ohio Sports Car Course and the standard waiver and release form furnished by BMW CCA Buckeye Chapter, Inc. prior to participation in the event.
