### General Safety

- Glass: no cracks; rear window unobstructed; wipers and blades in good condition
- Roll bar/cage: ample room in passenger seat; Any cage within 12" of driver/passenger must be padded with SFI 45.1 or FIA 8857-2001 Type A foam
- Seat belts: securely mounted; *equal restraints for driver and passenger's seat required; no exceptions*
- Seats: securely mounted, in good condition; *equivalent for driver and passenger recommended*
- Doors: must be operational from inside or outside

### Engine Compartment/Interior

- Battery: securely mounted; no leaks; cover on +
- Brake fluid: MUST have been changed within past 6 months. Date of change: \_\_\_\_\_
- No visible fluid leaks (gas, oil, coolant, hydraulics)
- Drive belts: tight and in good condition
- Radiator cap: pressure test
- Steering: no looseness, play or binding
- Brake lights, headlights: functioning properly
- Pedals: firm; no excessive travel; proper return
- Mirrors: secure; left side and interior required

### On Lift and Under Car

- Tires, sidewall and tread; no cracks, blisters, cord visible; minimum 2/32" tread for non-race tires
- Wheel bearings: free rotation; no looseness in hub
- Brakes: minimum 50% pad; rotors within specs; hoses, lines, calipers functioning, clean and dry
- Suspension: mounting points and shocks secure; no cracks, side-to-side variation or excessive rust
- Wheels: no cracked or bent rims; check lug torque
- Engine, transmission and differential mounts: secure and in good condition
- Drive and half shafts: no looseness; CV joints dry; Guibo, driveshaft center support bearing good
- Exhaust: securely mounted and in good condition  
*\*Excessively loud cars may be black-flagged until corrected.*
- Overall: no excessive body or chassis corrosion; no loose body or interior parts
